_____ Whether it is possible for your client to be returned home immediately or within the next six months, and if not, why it is not in your client's best interest to return home:

_____ Where your client's return home is unlikely within six months, whether legal guardianship or custody with a relative or some other suitable person should be established, and if so, the rights and responsibilities which should remain with the parents:

_____ Where your client's return home is unlikely within six months, whether adoption should be pursued, and if so, any barriers to his adoption:

_____ Where your client's return home is unlikely within six months, whether your client should remain in the current placement or be placed in another permanent living arrangement and why:

_____ Whether DFS has, since the initial permanency planning hearing, made reasonable efforts to implement the permanent plan for your client;
