**ORDER OF APPOINTMENT OF COUNSEL**

11 This case was referred to the Pilot Pro Bono Program (“Program”) adopted in General Order  
12 2014-01 for appointment of pro bono counsel to [Plaintiff/Defendant]. Having been informed that pro  
13 bono counsel has been identified and that pro bono representation has been agreed to by  
14 [Plaintiff/Defendant], [Pro Bono Counsel’s Name] is hereby appointed as counsel for  
15 [Plaintiff/Defendant]. The scope of appointment is for [all purposes through the conclusion of trial] [the  
16 limited purpose of \_\_\_\_\_]. Appointment under the Program does not extend to the appeal, if any, of  
17 a final decision. Accordingly,

18 **IT IS HEREBY ORDERED** that [Pro Bono Counsel] is hereby appointed as pro bono counsel  
19 for [Plaintiff/Defendant] under the United States District Court for the District of Nevada’s Pilot Pro  
20 Bono Program. The scope of appointment does not extend to the appeal, if any, of a final decision.

21 **IT IS FURTHER ORDERED** that appointed counsel may seek reimbursement of reasonable  
22 expenses or compensation for services in any manner authorized under the Program.

23 **IT IS FURTHER ORDERED** that the Clerk of Court shall assign a PROBONO case flag and  
24 add [pro bono counsel] to the docket as counsel of record for [Plaintiff/Defendant].

25 **IT IS FURTHER ORDERED** that [pro bono counsel] shall not be charged fees for use of the  
Court’s filing system in this matter for the duration of his/her appointment.
